**ORDER TO INVITE THE INTERNATIONAL INSTITUTE OF MUNICIPAL CLERKS
PRESIDENT, SHERI L. PIERCE TO THE MISSISSIPPI MUNICIPAL CLERKS AND
COLLECTORS' ASSOCIATION CONFERENCE DECEMBER 15-17, 2021**

There next came on for consideration the matter of the Mississippi Municipal Clerks and Collectors Association (MMCCA) inviting the International Institute of Municipal Clerks (IIMC) President, Sheri L. Pierce to the Mississippi Municipal Clerks and Collectors Association Conference, December 15 – 17, 2021. The Executive Committee first heard from Mary Ann Hess, a member of the MMCCA and the current IIMC Vice President. Mary Ann Hess explained the

importance in inviting the President to the State of Mississippi. Mary Ann also explained that if the invite was extended then the MMCCA would need to pay for the Presidents meals, hotel expenses and possibly a rental vehicle.
